



Age-Friendly Care System-wide Spread Self-Assessment

The System-wide Spread Self-Assessment is intended for health systems spreading the reliable provision of 4Ms care across their system. The assessment is designed to help systems identify strengths and opportunities as they relate to the drivers of spread of the 4Ms as described in the guide, <u>Spreading Age-Friendly Care</u>: <u>Drivers of Successful Health System-wide Spread of the 4Ms</u>.

We recommend that teams use the assessment to promote reflection and discussion among team members and system leaders at all levels. Questions to prompt discussion can be found at the bottom of the table.

Ask different team members, working at different levels of the organization, to complete the assessment individually. Then, compare results. Any variation in assessment can prompt meaningful discussion on perspectives and next steps.

We measure the impact of the 4Ms using process and outcome measures

We are tracking the financial impact of the 4Ms					
We display data over time and leverage it for internal quality improvement of 4Ms care

- What resources and supports are required to ensure our efforts are successful?
- Who needs to be involved in this work who is not already part of these efforts?

When looking at responses across different team members and stakeholders, discuss:

- Which domains had the widest variation in scores? What can we learn about these domains?
- Are there patterns related to who scored differently in specific domains in terms of role, department, tenure, etc.?
- What might these differences in assessment tell us about how to move forward?
